

DATABASE DETAILS

⊕ Radiation Information Database - The Radiation Information Database (RADInfo) contains information about facilities that are regulated by U.S. Environmental Protection Agency (EPA) regulations for radiation and radioactivity. RADInfo includes facility information for facilities regulated by these Code of Federal Regulation (CFR) parts: 40 CFR Parts 191 and 194; 40 CFR Part 61; and 40 CFR Part 300. 40 CFR Parts 191 and 194 are EPA's regulations governing the Department of Energy's Waste Isolation Pilot Plant (Part 194) and the management and disposal of spent nuclear fuel, and high-level and transuranic radioactive wastes (Part 191). EPA's regulations limiting the amount of radiation that can be released into the air from a number of different types of facilities are contained in 40 CFR Part 61, Subparts B, H, I, K, Q, R, T, and W. 40 CFR 300 establishes EPA's National Priority List (NPL), and RADInfo only contains information on radioactively-contaminated NPL sites. There are EPA regulated facilities that are not yet included in the RADInfo database, and they are nuclear fuel cycle facilities regulated by 40 CFR Part 190 and designated uranium and thorium mill tailings processing or depository sites regulated by 40 CFR Part 192.

Owners and operators of facilities or sites regulated by EPA must report certain information to EPA on a regular basis in order to demonstrate their compliance with the 40 CFR Part 61 regulations described above.

Because RADInfo is only based upon information provided by those sites and facilities regulated by EPA, there may be other facilities subject to EPA regulations that handle radioactive materials that are not included in RAD-Info. For example, phosphogypsum piles (also known as stacks) are regulated under 40 CFR 61, Subpart R, but the owners or operators of these stacks are not required to report to EPA until the stacks become inactive. Owners or operators of active phosphogypsum stacks are not required to report to EPA. Thus, information concerning these facilities are not be included in RADInfo. In addition, facilities with radioactive and hazardous (mixed) waste are generally not included in RADInfo.

National Priorities List - The National Priorities List (NPL) is the list of hazardous waste sites in the United States eligible for long-term remedial action (cleanup) financed under the federal Superfund program. Environmental Protection Agency (EPA) regulations outline a formal process for assessing hazardous waste sites and placing them on the NPL. Section 105(a)(8)(B) of CERCLA (CERCLA Overview) as amended, requires that the statutory criteria provided by the HRS be used to prepare a list of national priorities among the known releases or threatened releases of hazardous substances, pollutants, or contaminants throughout the United States. This list, which is Appendix B of the National Contingency Plan, is the NPL.

The identification of a site for the NPL is intended primarily to guide EPA in:

- Determining which sites warrant further investigation to assess the nature and extent of the human health and environmental risks associated with a site;
- Identifying what CERCLA-financed remedial actions may be appropriate;
- Notifying the public of sites EPA believes warrant further investigation; and
- Serving notice to potentially responsible parties that EPA may initiate CERCLA-financed remedial action.

Inclusion of a site on the NPL does not in itself reflect a judgment of the activities of its owner or operator, it does not require those persons to undertake any action, nor does it assign liability to any person. The NPL serves primarily informational purposes, identifying for the States and the public those sites or other releases that appear to warrant remedial actions.

For the purposes of mapping, region, or areas delineated for cleanup are identified on the map as a yellow highlighted symbol, and single sites are shown in a green circle, often with other facilities co-located.

• Toxics Release Inventory - The Toxics Release Inventory (TRI) is a publicly available database containing information on toxic chemical releases and other waste management activities in the United States. The TRI program tracks the management of toxic chemicals that may pose a threat to human health and the environment. The database is available from the United States Environmental Protection Agency (EPA) and contains information reported annually by some industry groups as well as federal facilities. Each year, companies across a wide range of industries (including chemical, mining, paper, oil and gas industries) that produce more than 25,000 pounds or handle more than 10,000 pounds of a listed toxic chemical must report it to the TRI. The TRI threshold was initially set at 75,000 pounds annually. If the company treats, recycles, disposes, or releases more than 500 pounds of that chemical into the environment (as opposed to just handling it), then they must provide a detailed inventory of that chemical's inventory.

In general, chemicals covered by the TRI Program are those that cause one or more of the following:

- Cancer or other chronic human health effects
- Significant adverse acute human health effects
- Significant adverse environmental effects

The current TRI toxic chemical list contains 594 individually-listed chemicals and 31 chemical categories (including four categories containing 68 specifically-listed chemicals). If the members of the four delimited categories are counted as separate chemicals, the TRI Program covers 689 chemicals and chemical categories (i.e., 594 + 27 + 68).

• **Resource Conservation and Recovery Act** - Sites subject to corrective action - The Resource Conservation and Recovery Act (RCRA), enacted in 1976, is the principal federal law in the United States governing the disposal of solid waste and hazardous waste. Congress enacted RCRA to address the problems the nation faced from its growing volume of municipal and industrial waste with goals of:

- Protecting human health and the natural environment from the potential hazards of waste disposal.
- Energy conservation and natural resources.

- Reducing the amount of waste generated, through source reduction and recycling
- Ensuring the management of waste in an environmentally sound manner.

RCRA sites subject to corrective action include many current and former chemical manufacturing plants, oil refineries, lead smelters, wood preservers, steel mills, commercial landfills, and a variety of other types of entities. Due to poor practices prior to environmental regulations, Corrective Action facilities have left large stretches of river sediments laden with PCBs; deposited lead in residential yards and parks beyond site boundaries; polluted drinking water wells in rural areas with chlorinated solvents; tainted municipal water supplies used by millions; and introduced mercury into waterways, necessitating fish advisories. At these sites, the RCRA Corrective Action Program ensures that cleanups occur. EPA and state regulators work with facilities and communities to design remedies based on the contamination, geology, and anticipated use unique to each site.

• Cortese Solid Waste Disposal Sites - These sites are identified by Water Board with waste constituents above hazardous waste levels outside the waste management unit- The provisions in Government Code Section 65962.5 are commonly referred to as the "Cortese List" (after the Legislator who authored the legislation that enacted it). The list, or a site's presence on the list, has bearing on the local permitting process as well as on compliance with the California Environmental Quality Act (CEQA). Subsection 65962.5. (c) states the State Water Resources Control Board shall compile and update as appropriate, but at least annually, and shall submit to the Secretary for Environmental Protection, a list of all of solid waste disposal facilities from which there is a migration of hazardous waste and for which a California regional water quality control board has notified the Department of Toxic Substances Control pursuant to subdivision (e) of Section 13273 of the Water Code. While many of these sites reside in other CalEPA databases, they are called out here for emphasis because it has been determined they have hazardous waste levels outside the property owned by the waste management unit.

Air Facility System - The Air Facility System (AFS) contains compliance and permit data for stationary sources of air pollution (such as electric power plants, steel mills, factories, and universities) regulated by EPA, state and local air pollution agencies. The information in AFS is used by the states to prepare State Implementation Plans (SIPs) and to track the compliance status of point sources with various regulatory programs under Clean Air Act.

The air release information provided in this report specifically relates to industrial plants and their components (stacks, points, and segments). This data provides valuable information not only about the industrial facilities, but about the chemicals they introduce into your local air. Envirostor - The Department of Toxic Substances Control (DTSC) website Site Mitigation and Brownfields Reuse Program Envirostor Database (Envirostor) database provides information on properties in California where hazardous substances have been released or where the potential for a release exists. The database includes information on Federal Superfund sites (NPL), state response sites, voluntary cleanup sites, school cleanup sites, permitted sites, and corrective action sites. In addition, information is provided to those who may want to purchase a site profile report, or request special database reports. The Envirostor list is derived from the DTSC's Site Mitigation and Brownfields Reuse Program's Envirostor database, and identifies sites that have known contamination or sites for which there may be reasons to investigate further. The database's public website provides access to detailed information on hazardous waste permitted and corrective action facilities, as well as existing site cleanup information. EnviroStor allows you to search for information on investigation, cleanup, permitting, and/or corrective actions that are planned, being conducted or have been completed under DTSC's oversight.

Envirostor - Hazardous waste facilities - A hazardous waste is a waste with a chemical composition or other properties that make it capable of causing illness, death, or some other harm to humans and other life forms when mismanaged or released into the environment.

Geotracker - is the California State Board's internet-accessible database system used by the State Board, regional boards, and local agencies to track and archive compliance data from authorized or unauthorized discharges of waste to land, or unauthorized releases of hazardous substances from underground storage tanks. This system consists of a relational database, on-line compliance reporting features, a geographical information system (GIS) interface and other features that are utilized by the State Board, regional boards, local agencies, regulated industry and the public to input, manage, or access compliance and regulatory tracking data. GeoTracker was developed pursuant to a mandate by the California State Legislature (AB 592, SB 1189) to investigate the feasibility of establishing a statewide GIS for leaking underground fuel tanks (LUFT) sites.

The online GeoTracker database (1) provides access to statewide environmental data and (2) tracks regulatory data for the following types of sites:.

- Leaking Underground Storage Tank (LUST) cleanup sites
- Cleanup Program Sites (CPS; also known as Site Cleanups [SC] and formerly known as Spills, Leaks, Investigations, and Cleanups [SLIC] sites)
- 🔲 Military sites (consisting of: Military UST sites; Military Privatized sites; and Military Cleanup sites [formerly known as DoD non UST])
- Land Disposal sites (Landfills)
- Permitted Underground Storage Tank (UST) facilities.
